### RESOLUTION No 016

#### **Withdrawal of assets in order to build a world free of nuclear weapons and stop the arms race actively developed by NATO.**

*We are guided by previous resolutions and statements of the International Treasury Monetary One,*

*Reaffirming* Resolution No. 1 (001/RES2020) of April 07, 2020 "On the way out of the global financial crisis", Resolution No. 2 (002/RES2020) of June 02, 2020 "The only way out of the global financial crisis", Resolution No. 4 (004/RES2021) of February 23, 2021 "Cancellation of historical assets in order to form a balanced new financial system", Resolution No. 5 (005/RES2021) of July 16, 2021, Resolution No. 6 (006 /RES2021) of September 13, 2021, Resolution No. 7 (007/RES2021) of October 01, 2021, Resolution No. 8 (008/RES2021) of December 21, 2021, Resolution No. 9 (009/RES2021) of December 22, 2021 "Reform of the global financial and economic system and its architecture", Resolution No. 11 (011/RES2022) of January 22, 2022 "On the termination of all relations with the well-known surname of financiers Rothschild", Resolution No. 12 (012/RES2022) dated February 27, 2022 "Revocation of all Asset Rights from the Trilateral Commission of the Trillennium Gold Reserve and New World Order Financial System Trusts", Resolution No. 13 (013/RES2022) dated March 01, 2022 "Determining the role of the State Bank of the USSR in restructuring the global financial and economic

system and its architecture, activating new functions", Resolution No. 14 (014/RES2022) dated March 03, 2022 "Revocation of assets in order to prevent the Third World War and prevent the return of Nazism", Resolution No. 15 (015/RES2022) of March 13, 2022 "Withdrawal of assets in order to eliminate all forms of discrimination, genocide of peoples",

*We remind* that the end of the Second World War was the beginning of an era of a new alignment of forces in the international field. Two opposing groupings of states united around the USSR and the USA, forming a bipolar model of the world. One of the symbols of the beginning of the Cold War was the North Atlantic Alliance (NATO), created on April 4, 1949 as an anti-Soviet military-political bloc. There are currently 30 countries in the alliance.

The declared goals of NATO concern exclusively security, freedom and democracy. This organization, created for defense purposes, sets itself the task of maintaining stability throughout the world, settling geopolitical unrest, protecting democracy, human rights and the borders established after the Second World War. However, it should be noted that in recent decades, NATO has been using very dubious means to achieve its goals. Thus, in 1995 and 1999, NATO armed forces used many types of prohibited weapons in the territory of the former Yugoslavia, and at the moment the phrase "peacekeeping bombing" has become a catch phrase. NATO is also interested in the countries of Central and Central Asia, the Middle East and Africa. NATO traditionally considers the Soviet Union, Russia and China to be its adversaries;

*Today* they will not remember, but in 1954 the USSR applied for NATO membership, but the application was rejected - the North Atlantic Alliance was originally created precisely as a counterbalance to the powerful Soviet Union;

*Paying* attention to the terrible arithmetic of NATO operations, since its inception, more than three million people have been killed by NATO armed forces as a result of 60 invasions of sovereign states. The list of crimes against countries, peoples, is so long that the Nuremberg trials can consider these crimes for decades in order to bring those responsible to punishment.

*Please note* that the echo of the war crimes of the Ukrainian security forces still reaches the Donbass. The result of regular shelling of settlements with the use of indiscriminate lethal weapons was the death and injury of thousands of Russian-speaking civilians. The intent to destroy or genocide the inhabitants of Donbass is obvious. This is evidenced by spontaneous common unmarked graves, forcibly formed outside specially designated places. In August-October 2021, five such mass graves were discovered in the region of Pervomaisk (the Luhansk People's Republic), of which the remains of at least

295 civilians who died as a result of shelling by the Ukrainian security forces in 2014 were exhumed. It is already known that among the remains there are bodies of women of different ages. We are talking about the cruel treatment of the civilian population, the use of means and methods in an armed conflict that are prohibited by international humanitarian law;

*We still have not* heard that the Western and Europe "civilized" community has given a strong assessment of these war crimes. We believe that our colleagues are well aware that in this way they give the Kiev nationalist regime "carte blanche" to continue armed violence against the inhabitants of the Donetsk People's Republic and the Luhansk People's Republic. The consequences are not long in coming, and we are witnessing a theater of military operations on the territory of Ukraine;

*March 14, 2022* in a residential area of the city of Donetsk, a tactical missile "Tochka-U" was hit. 20 civilians were killed. Another 28 people were seriously injured. Equipping the warhead of the rocket with cluster munition proves that the purpose of the nationalist strike on the city was to kill the maximum number of civilians. The shelling was carried out from the north-western direction, from the area of the settlement of Krasnoarmeysk, which is controlled by Ukrainian units. We emphasize that the use of cluster munitions in residential areas of the city, where there are no firing positions, is a war crime. This type of weapon is prohibited for use by international agreements. However, again, neither the OSCE Chairmanship-in-Office nor any of the participating States condemned this act of aggression. We see that, according to the Western and Europe "civilized" community, People are divided into those who are worthy of protection and those who, for some reason, are not worthy of it. Such is "civilized" behavior and "commitment" to international humanitarian law;

*In this regard*, we remind, addressing the states separately, the principle of equality in dignity and rights of all Humans and all Nations, regardless of race, nationality, color and origin, is a generally accepted principle recognized in international law. Consequently, any form of discrimination carried out by a state is a violation of international law, entailing the international responsibility of the state;

*The cynicism* of the organizers of this act of state terrorism was also manifested in the fact that two days before it, the Ukrainian side began circulating in social networks calls for the mothers of the Donetsk People's Republic to come to the city administration of Donetsk in order to find out the fate of their sons. It was at the place and at the time indicated in these appeals that the dastardly blow was dealt;

*Please note* that at present, the countries of NATO and the European Union, ignoring international norms and their own rules, are supplying lethal weapons to Ukraine

and sending mercenaries to kill Russian servicemen. The entire responsibility for the death of this category of foreign citizens in Ukraine rests solely with the leadership of the countries sending them. *The International Treasury Monetary One* expresses its concern about the connection between mercenarism and illegal arms trafficking, which contribute to fueling and continuing the conflict in Ukraine;

*These days*, fears have been confirmed regarding the development by the United States on the territory of Ukraine of appropriate biological materials for military purposes under the auspices of the US intelligence services. Indicative here is the extreme nervousness of officials from the US administration in connection with the discovery of their weapons bio-development on the territory of Ukraine. At the disposal of the *International Treasury Monetary One* were documents that confirm that a network of at least 30 (thirty) biological laboratories has been formed on the territory of Ukraine, in which extremely dangerous experiments are carried out aimed at enhancing the pathogenic properties of plague, anthrax, tularemia, cholera and other deadly diseases using synthetic biology. The research results were sent to the US military biological centers, incl. to the U.S. Army Medical Research Institute of Infectious Diseases, the Walter Reed Army Research Institute, the U.S. Naval Medical Research Center, and the military laboratories at Fort Detrick, formerly key sites of the U.S. biological weapons program. In practice, the US-implemented program of the so-called "reform" of the Ukrainian healthcare system has led to an increase in the incidence of especially dangerous infections among Ukrainians, including rubella, diphtheria and tuberculosis. The incidence of measles has increased more than 100 times. With a high degree of probability, we can say that one of the tasks of the United States and its allies in Ukraine was the creation of bioagents capable of selectively affecting various ethnic groups of the population.

*The International Treasury Monetary One recognizes* that an ever-wider degree of agreement and cooperation between countries is required to effectively address international problems,

Nazism", Resolution No. 15 (015/RES2022) of March 13, 2022 “Withdrawal of assets in order to eliminate all forms of discrimination, genocide of peoples”, **continue actively blocking all system access codes for accounting, distribution and control of assets that these groups and all their affiliated organizations, banks, companies had, strives to create conditions under which all states will be able to use all their resources to solve the task of improving the well-being of their Peoples, without fear of any coercion, threat or use of force,**

*The International Treasury Monetary One* notes the growing interest and increased desire for detente in recent years, convinced of the urgent need for additional efforts to expand this trend so that it covers all areas of the world and contributes to the settlement of outstanding international problems by peaceful means through the participation and cooperation of states,

*The International Treasury Monetary One* recognizes that the continuation of a policy of confrontation and rivalry between states or groups of states is incompatible with the détente of international tension,

*The International Treasury Monetary One* reaffirms the indivisibility of the world and security in all areas of the world and the growing interdependence between countries, and therefore strives to achieve the elimination of all sources of political tension and friction,

*The International Treasury Monetary One* is convinced that confidence-building measures could contribute to defusing international tensions,

*The International Treasury Monetary One* is also convinced that progress in negotiations on arms limitation and disarmament, especially in the field of nuclear weapons, and the elimination of the threat of war are of great importance for the continuation of detente and the further development of friendly relations between states,

*The International Treasury Monetary One* is convinced that the establishment of fair and equitable economic relations between states is an important condition for true and lasting peace and harmony between countries,

*The International Treasury Monetary One* is also convinced of the need to eliminate all forms of aggression, foreign occupation and interference in the internal affairs of other states, to ensure respect for Human Rights and the need to eliminate colonialism through the free exercise of the right to self-determination and the eradication of racism and apartheid, as well as other forms of injustice,

*The International Treasury Monetary One*, guided, therefore, by the need for all states, based on the highest interests of peace and the future of humankind, intends to

continue efforts towards further detente, developing better relations between countries, and for these purposes, following the implementation of the tasks set, has come to the final, an irreversible solution, and **introduces the following solutions:**

We withdraw all Rights to assets that were previously transferred under management and disposal in the following Countries, Organizations, Groups, Persons placed in central, national and / or state banks, commercial banks, in different countries around the World:

**NATO - North Atlantic Treaty Organization, North Atlantic Alliance**

**AUKUS - trilateral security pact between Australia, the United Kingdom, and the United States**

We activate the blocking of all system access codes for accounting, distribution and control, which these groups and all their affiliated organizations, banks, companies had.

In connection with the transfer of assets to our full disposal and management, observing all the norms of International Law, the assets are entered into the balance of the *International Treasury Monetary One*. In this regard, we strongly recommend starting the procedure of removal from the balance of these assets and all securities, formed on the basis of these assets and gradually begin the liquidation of valid and Fiat financial resources received during the period of using these assets;

There is no possibility to consider the preservation of formed securities, valid and fiat financial resources, on the basis of assets that have not been put into use and have not been sent to social projects up to this point. Likewise, consideration of proposals is impossible;

From the moment of receipt of this notification, to make the necessary system notifications in the Global Financial System within 48 hours, in order to notify all banking and interbank organizations in a timely manner, we instruct your esteemed Organization;

*We remind* that any actions using the above assets for the purpose of monetization in the financial system are a crime and are the personal and individual responsibility of persons, officials and bank officers who commit these crimes;

*We remind* that in order to prevent fraud and deception of bona fide subjects of Law, it is prescribed to transfer the register of documents for entry into the liquidation memorandum for the purpose of accounting, analysis, and evaluation of the integrity of Ex-guardians, Ex-holders, and Ex-managers of the Right to manage historical assets of the Global Financial System;

*We remind*, the Sacred Rights of the Guardians of the above assets have been revoked, and any actions contrary to the Resolution of the International Treasury No. 4 (004/RES2021) dated February 23, 2021 «The cancellation of historical assets in order to form a new well-balanced financial system» will have immediate (inescapable) sacred and obvious consequences for the Guardians with manifestation in the material world.

***The International Treasury Monetary One declares its determination to:***

- identify bank accounts, assets and actively block all system access codes for accounting, distribution and control of assets that the groups and all their affiliated organizations, banks, companies had in order to eliminate the causes and consequences of international tension in order to promote a peaceful and speedy settlement unresolved international problems, and seek to eliminate both the causes and the consequences of international tension in a manner that relations between all states may develop in the direction of cooperation and friendship with a view to preventing the occurrence of situations that could endanger international peace and security;
- firmly adhere to and promote the implementation of universally recognized principles and declarations aimed at strengthening international peace and security and developing friendly and cooperative relations among states, as well as fulfill their obligations to provide financing for sustainable development arising from multilateral treaties and agreements that serve to achieve these goals;
- to strengthen the role of the *International Treasury Monetary One* as one of the main instruments in the maintenance of international peace and security by strengthening the Organization's capabilities in the field of ensuring and maintaining peace;
- refrain from the threat or use of force and observe in their relations with other states the principles of sovereign equality, territorial integrity, inviolability of interstate borders, inadmissibility of the acquisition and occupation of the territory of other states by force, settlement of disputes, including border disputes, by purely peaceful means, renunciation of intervention and interference in the internal affairs of other states, adhere to respect for the Human rights, respect for the right of all countries to freely choose their social, political and economic systems and develop their external relations in such a way that they consider the most consistent with the interests of their Peoples;
- ensure the free exercise of the right of Peoples under colonial and foreign domination to self-determination and promote majority rule, especially where racial oppression and, in particular, apartheid, have deprived Peoples of the opportunity to exercise their inalienable rights. In this regard, assist in the formation of the necessary measures and the provision of non-refundable funding;

- strive to establish and develop fair and balanced economic relations between states and reduce the gap between developed and developing countries in accordance with the financing plans adopted by the *International Treasury Monetary One* on the basis of consensus on the establishment of a new international economic order, and the formation of a new architecture of the world financial system;
- encourage mutual understanding and trust between Humans by developing and facilitating cultural exchanges, freer movement and contacts between them, both individually and collectively. In this regard, we declare that there are all opportunities for financing cultural and educational programs free of charge;
- to continue to develop their relations and cooperation in accordance with the purposes and principles of the *International Treasury Monetary One* in the Divine laws of Creation and to comply with the resulting principles set out above, recognizing that nothing in this Resolution can neither change nor diminish the obligations that the *International Treasury Monetary One* has taken on themselves in relation to other states in accordance with the principles of international law.
