We hereby confirm that on the basis of the Decree of the Military People's Council of the USSR: State Decree of the USSR No. 81-6 dated October 07, 2018 On restore the operation of the Treasury of the Union of Soviet Socialist Republics, the International Treasury Monetary One performs the function of the Treasury of the Union of Soviet Socialist Republics. The post of Treasurer of the Union of Soviet Socialist Republics is entrusted to His Majesty Alexander Nikolaevich Paramonov, Secretary General and Chief Treasurer of the International Treasury Monetary One.

We hereby confirm that the decision of the Congress of People's Deputies of the Union of Soviet Socialist Republics of March 14, 1990 No. 1360-I (Law of the Union of Soviet Socialist Republics of March 14, 1990 No. 1360-I "On the establishment of the post of President of the Union of Soviet Socialist Republics and excluded Articles No. 6 «On the Leadership Role of the Central Committee of the Communist Party» from the Constitution of the Union of Soviet Socialist Republics, Amendments and Additions to the Constitution (Basic Law) of the Union of Soviet Socialist Republics") is illegitimate and illegal as the Congress of People's Deputies The Union of Soviet Socialist Republics was

first opened in May 25, 1989 in the city of Moscow and is the Highest legislative Organ of the Union of Soviet Socialist Republics, but within the framework of the Constitution of the Union of Soviet Socialist Republics of October 07, 1977, without the right to make amendments and additions to the Constitution of the Union of Soviet Socialist Republics of October 07, 1977.

On the basis of Exclusive Historical Law, the Right of the Sovereign, by the Right of the Owner of All World Assets from the Creator of the New Era and by the Right of the Main Regulator of the World Financial System, We confirm that on the basis of the Right of the Sovereign of the Union of Soviet Socialist Republics, on the basis of International Law, the Sovereign Country of the Union of Soviet Socialist Republics is the Sovereign and acting Subject of International Law together with Sovereign Citizens Of The Union Of Soviet Socialist Republics,

Performing the function of the Treasury of the Union of Soviet Socialist Republics, the International Treasury Monetary One, together with officers of several International System Banks, conducted an inspection of the placed gold and foreign currency deposits of the International Organization "Socialist International" (Socintern), headed by Nikolai Petrovich Trusov. As a result of the audit, the history of the funds of these deposits showed that these assets were illegally taken (stolen) from the Sovereign, the Union of Soviet Socialist Republics and the Sovereign People of the Union of Soviet Socialist Republics for the purpose of embezzlement, criminal enrichment and possible financing of corruption and international terrorism. During the investigation with the help of the State Security Committee of the Union of Soviet Socialist Republics, as well as International Law Enforcement and Counter-Terrorism Organizations, only in one of the many episodes it became clear that in the 1980s and 1990s criminal officials of the highest leadership level of the Union of Soviet Socialist Republics and the First Secretary of the Central Committee of the Communist Party of the Soviet Union Gorbachev M.S., and later, the illegitimate President Mikhail Gorbachev, together with the President of the Russian Soviet Federative Socialist Republic Yeltsin Boris (suspended for illegal actions from the post of President of Russia (CONSTITUTIONAL COURT OF the RUSSIAN FEDERATION CONCLUSION No. Z-2 of September 21, 1993), acting on a criminal plan to rob a Sovereign Country, Sovereign People, Sovereign Citizens of the Union Of the Soviet Socialist Republics, organized embezzlement and theft of assets of the Union of Soviet Socialist Republics. The stolen assets from the Sovereign were transferred in various criminal ways to the International Organization "Socialist International" (Socintern), shaming and denigrating the worthy name of the organization.

We affirm that this crime is absolutely unacceptable and violates the most serious articles in the field of criminal law of a Sovereign Country of the Union of Soviet Socialist Republics, subjects and sub-subjects of the Law of the Union of Soviet Socialist Republics, and in the field of International Criminal Law.

In order to restore Justice, on the basis of Exclusive Historical Law, the Right of the Sovereign, by Right of the Owner of All World Assets from the Creator of the New Era and by Right of the Main Regulator of the World Financial System: I deprive the International Organization "Socialist International" (Socintern), headed by Nikolai Petrovich Trusov, of Legal Personality and outlaw it.

Based on the above, we decide:

The international organization "Socialist International" (Socintern), headed by Nikolai Petrovich Trusov, recognized as criminal and outlawed throughout the World.

To all Law Enforcement and Counter-Terrorism Country and International Organizations, Country and International Financial and Banking Control Organizations, all officers and employees of Country and International Financial and Banking Systems, immediately monitor, audit, block, arrest and confiscate with transfer to the International Treasury Monetary One in order to transfer to the Balance of the Treasury of the Union of Soviet Socialist Republics all accounts and all assets and profits earned on their basis of the criminal International organization "Socialist International" (Socintern), headed by Nikolai Petrovich Trusov, the leadership of the International criminal Organization "Socialist International" (Socintern) and legal entities affiliated with them.

The entire leadership of the International Criminal Organization "Socialist International" (Socintern) and all subjects of law guilty of the above-described monstrous crime, subject to criminal punishment to the fullest extent of the Law of a Sovereign Country of the Union of Soviet Socialist Republics, subjects and sub-subjects of the Law of the Union of Soviet Socialist Republics and International Criminal Law.

I leave control over the execution of this resolution to the Security Department of the International Treasury Monetary One and the International Counter-Terrorism Organization: the State Service «Union Counter-Terrorism» of Committee for State Security of the Union of Soviet Socialist Republics (registration with the United Nations No. 629055.)
